D. Matter of new business to be presented to the Court for its consideration and action as appropriate

Item #1: Discussion of proposed budgets with various elected officials. The following officials were present to address the Court:

Donnie Barnum, Constable Precinct #1/allocated \$12,000 salary plus \$3,000 for operating expenses/requested \$18,000 salary and \$9,000 for operating expenses

Mike Barr, Deputy Constable Precinct #3 and Attorney Lance Wyatt, Texas Municipal Police Officers Association/no salary or expense budget allocated/requested no salary, only operating expenses

C.T. Ham, Constable Precinct #3 and Attorney Lance Wyatt/ allocated \$24,000 salary and \$6000 operating expenses/requested an additional \$3,000 for operating expenses (because of the price of gasoline)

Constable Precinct #4 Belinda Salyer/ allocated \$12,000 salary and \$3,000 for expenses/requested \$18,000 salary and \$9000 for operating expenses

Judge West called for a five minute recess.

After the Court reconvened Sheriff Grubbs and Chief Deputy Sheriff Duvall appeared and requested the following:

Allocated in the proposed budget: one jail Sergeant and three jailers/requested one deputy, 1 jail Sergeant and 3 jailers.

Speaking from the audience was:

Justice of the Peace #2 Bob Wall in support of Mike Barr

Bob Stegar in support of all additional law enforcement personnel

Commissioner Adams moved that the Court recess until 1:00 P.M.

Commissioner Carroll seconded the motion and the Court voted 4-0 to approve.
