**A. Opening prayer. Commissioner Beck led the Court in the invocation.**

**B. Reading and approval of minutes. Commissioner Gist moved that the minutes of the June 5, 2006 meeting be approved, as presented by County Clerk Margaret Wood. Commissioner Beck seconded the motion and the Court voted 4-0 to approve.**

**Item #1: Air Evac-consideration and approval to authorize subscription emergency services. After a presentation by Burt League, AirEvac Lifeteam, Commissioner Adams moved that the Court authorize AirEvac Lifeteam to sell subscriptions, for emergency prehospital care, within the Brown County service area. Commissioner Beck seconded the motion and the Court voted 4-0 to approve.**

**Item #2: Approval of Internet policy to be an addendum to the Brown County Personnel Manual. Commissioner Carroll moved that the Court adopt a Internet Acceptable Use Policy, as a addendum to the Brown County Personnel Manual. **E. Reports. Ann Krpoun, County Treasurer, presented the June 9, 2006 Cash Statement Report, for filing. (Exhibit #3)**

**Commissioner Carroll reported that trucks with heavy loads have caused serious damage to County Roads #136 and #155, in Precinct #4. The Court discussed the establishment of load limits on County Roads.**
