**Item #1: Adopt tax rate FY 2006/2007. Commissioner Carroll moved that the Brown County Property Tax be increased by the adoption of a total tax rate of 0.5505. Commissioner Adams seconded the motion and the Court voted 4-0 to approve. Commissioner Gist was absent. (Exhibit #1)**

**Item #2: Adopt budget for FY 2006/2007. Judge West moved that the Brown County Budget for 2006/2007 be adopted, as submitted by County Auditor Nina Cox. Commissioner Beck seconded the motion and the Court voted 4-0 approve. Commissioner Gist was not present. (Exhibit #2)**

**Item #1: Consideration and approval of Brown County Fees of Office. Commissioner Adams moved that Brown County Fees of Office, as presented by Chief Deputy Sheriff Bobby Duvall, be approved, with the exception of the inclusion of "writ of garnishment" on page 1, paragraph 1. Commissioner Beck seconded the motion and the Court voted 4-0 to approve. (Exhibit #3)**
