**A. Opening prayer. Commissioner Gist led the Court in the invocation.**

**B. Reading and approval of minutes. Commissioner Gist moved that the minutes of the April 9, 2007 meeting be approved, as presented by County Clerk Margaret Wood. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.**

**C. Recognition of visitors.**

**D. Matter of new business to be presented to the Court for its consideration and action as appropriate**

**Item #1: Chandra Mosley-Proclamation declaring week of April 16<sup>th</sup> through April 21<sup>st</sup> as National Volunteer Week. Commissioner Adams moved that Brown County proclaim that the week of April 16<sup>th</sup>**

**through April 21<sup>st</sup> be declared National Volunteer Week. Commissioner Kelton seconded the motion and the Court voted 5-0 to approve.**

**Item #2: Sheriff's Office-discussion and action on personnel. After a presentation by Sheriff Grubbs and Chief Deputy Sheriff Bobby Duvall, Commissioner Adams moved that the Court approve the conversion of the transportation officer (jailer) to a deputy position and to approve the employment of John Flores in that position, effective May 1, 2007. Commissioner Gist seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)**

**Item #3: Richard Gist, Precinct #3-approval of Resolution to change voting lines. Commissioner Gist moved that the Court approve a Resolution modifying the boundaries of Voting Precinct #307 (Blanket) and Voting Precinct #308 (Zephyr), in Commissioner Precinct #3. Commissioner Traweck seconded the motion and the Court voted 4-0 to approve. (Exhibit #3)**

**Item #4: Ann Krpoun-request and permission to purchase filing cabinets. Commissioner Adams moved that Treasurer Ann Krpoun, be authorized to purchase five filing cabinets (a budgeted item), from Staples (\$323.99 per cabinet). Commissioner Kelton seconded the motion and the Court voted 4-0 to approve. (Exhibit #4)**

**E. Reports. The April 16, 2007 Cash Position Statement was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #5)**

**F. Consideration and approval of bills. Commissioner Traweck moved that the claims, presented by County Auditor Nina Cox, be paid.**

**Commissioner Gist seconded the motion and the Court voted 4-0 to approve. (Exhibit #6)**

**G. Recess. Commissioner Kelton moved that the Court recess until Friday, April 20, 2007 at 8:00 A.M. The Court will meet at the Brownwood Regional Airport for a trip to Fort Hood. Commissioner Traweck seconded the motion and the Court voted 4-0 to approve.**
