**Item #2: Sheriff's Office-Consideration and possible approval of Annual Mentalix Maintenance Agreement. Commissioner Traweek moved that the Sheriff's Department be authorized to renew their yearly contract, with Mentalix, Inc., for technical support and updates, for their Live Scan System. The renewal price, of \$3,465.00 per year, will be paid from the Sheriff Department's Supplies Fund.**

**Commissioner Gist seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)**

**Item #3: Steve Adams, Precinct #1-Consideration and possible approval to purchase equipment. Commissioner Adams moved that he be authorized to purchase a 1998 International dump truck, from TXIW Co. for \$18,500.00, for Precinct #1. Commissioner Kelton seconded the motion and the Court voted 4-0 to approve.**
