Now, therefore, the parties agree as follows:

1. Exhibit A Fees to the Agreement shall be changed as follows:

 - b. Retail Pharmacy Fees Brand and Generic dispensing fees shall be changed to \$3.00.
2. Except as expressly set forth herein, all terms of the Agreement shall remain unchanged and in full force and effect. To the extent that there are any inconsistencies between the Agreement and this Amendment, this Amendment shall govern. Client shall not add, delete, or otherwise alter this Amendment without the prior written agreement of IPM. Any such alteration shall have no effect.
