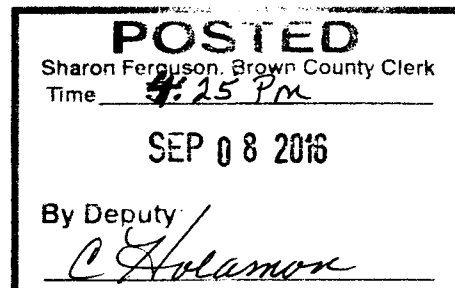

**The Brown County Commissioners Court convened in a Special Session on September 12, 2016 at 9:00 A.M. in the Commissioner's Courtroom, Brown County Courthouse, 200 South Broadway Brownwood, Texas. Judge Pro-Tem Kelton called the meeting to order at 9:10 A.M. Members of the Court present were:**

- A. Opening prayer. Rick Phelps led the Court in the invocation.**
- B. Reading and approval of minutes. None.**
- C. Recognition of visitors.**
- D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.**

**Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.**

**Item #2: Robert Mullins, Constable-Consideration and possible approval of Sheriff and Constable Fees. After discussion, with Constable Precinct #1 Robert Mullins, Commissioner Worley moved that the Court approve the proposed Brown County 2017 Sheriff/Constable Fees, with no increases or changes for the Constables or the Sheriff's Department. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #1)**

**Item #3: Sharon Ferguson, County Clerk-Public Hearing on preservation and restoration of the County Clerk's Archive. Judge Pro-Tem Kelton opened the public hearing on the preservation and restoration of the County Clerk's Archive Plan and asked for questions or comments, from the audience. There were none. Judge Pro-Tem Kelton recessed the public hearing.**

**Item #4: Sharon Ferguson, County Clerk-Consideration and possible approval of County Clerk's Records Archival Plan/Fee. After discussion, Commissioner Worley moved that the Court sign an order to adopt the County Clerk's Records Archival Plan/Fee presented by County Clerk Sharon Ferguson. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)**

**Item #5: Cheryl Jones, District Clerk-Public Hearing on preservation and restoration of the District Clerk's Records Archive. Judge Pro-Tem Kelton opened the public hearing on the preservation and restoration of the District Clerk's Archive Plan and asked for questions or comments, from the audience. There were none. Judge Pro-Tem Kelton recessed the public hearing.**

**Item #8: Ray West, County Judge-Public Hearing on proposed tax rate. Judge West opened the second public hearing, on the proposed tax rate, for public comment or questions. Tommy Blevins complimented T'Anna McClure, Administrative Assistant to the Commissioner's Court, on a job well done. Judge West recessed the second public hearing.**

**Item #9: Ray West, County Judge-Consideration and possible approval of 2017 County Holidays. Commissioner Traweek moved that the Court adopt the Brown County Proposed Holidays for Calendar Year 2017, as listed in Exhibit #5 to these minutes. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #5)**

**Item #10: Ray West, County Judge-Consideration and possible approval to approve regular meeting dates for 2016/2017. Commissioner Worley moved that the Court approve the second Monday of each month as the regular meeting dates for Commissioner Court for 2016/2017, beginning October 1, 2016. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.**

**Item #11: Ray West, County Judge-Consideration and setting of date to approve budget for FY 2016-2017. Commissioner Shaw moved that the Court approve Wednesday, September 21, 2016, at 9:00 A.M., as the date and time to approve the Brown County budget for FY 2016/2017. Commissioner Kelton seconded the motion and the Court voted 5-0 to approve.**
