RESOLUTION AUTHORIZING COUNTY GRANT

A resolution of the County of Brown Texas (County) certifying that the county has made a grant to Brownwood Senior Citizens - City of Brownwood, (Organization) an organization that provides home-delivered meals to homebound persons in the county who are elderly and/or have a disability and certifying that the county has approved the organization's accounting system or fiscal agent.

WHEREAS, the Organization desires to apply for grant funds from the Texas Department of Agriculture to supplement and extend existing services for homebound persons in the County who are elderly and/or have a disability, pursuant to the Home-Delivered Meal Grant Program (Program); and

WHEREAS, the Program rules require the County in which an Organization is providing home-delivered meal services to make a grant to the Organization, in order for the Organization to be eligible to receive Program grant funds; and

WHEREAS, the Program rules require the County to approve the Organization's accounting system or fiscal agent, in order for the Organization to be eligible to receive Program grant funds.

WHEREAS, the County recognizes Brownwood City Manager Emily Crawford (Authorized Official) as an official of the Organization.

BE IT RESOLVED BY THE COUNTY:

SECTION 1: The County hereby certifies that it has made a grant to the Organization in the amount of \$84,198 to be used between the:

SECTION 2: The County hereby certifies that the Organization provides home-delivered meals to homebound persons in the County who are elderly and/or have a disability.

SECTION 3: The County hereby certifies that it has approved the Organization's accounting system or fiscal agent which meets financial management system requirements as set forth in Uniform Grant Management Standards.

- In 2013 - \$3,122.16
- In 2014 - \$4,836.02
- In 2015 - \$7,007.44
- In 2016 - \$9,490.37

The grant name is "Texans Feeding Texans: Home-Delivered Meal Grant Program" www.TexasAgriculture.gov this grant program is setup to give dollars to Home Delivered Meal Programs in Texas. The actual amount of the grant depends on how many organizations in the State of Texas will apply for this grant and available State Funding. The grant requirements is based on the following items:

- **This grant is not eligible for meals that are already funded by Title #3, #19, and #20.**
- **If a county has multiple meal providers, the individual county qualifying grants will be totaled to determine the County's overall participation level.**
- **In 2015/2016 Brown County donated \$75,572 or about 14.8% of the total income of the program.**
- **Deadline to apply for the "Texans Feeding Texans: Home Delivered Meal Grant Program is November 1, 2016.**
- **We should know the grant amount that is awarded in January 2017.**
