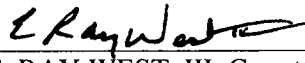

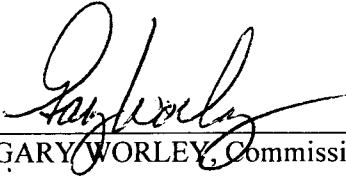

AFFIDAVIT

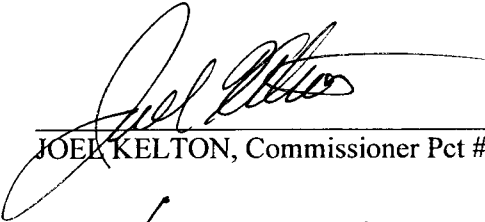

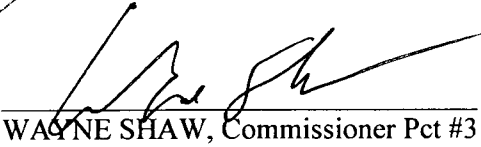

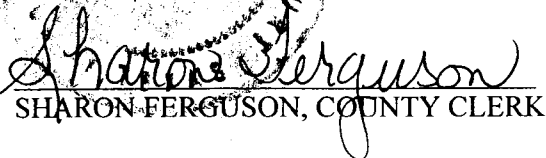
