- A. Opening prayer. Rick Phelps led the Court in the invocation.**

Bart Johnson, Brown County Agent of Record, from Painter And Johnson Financial, presented the Brown County BCBS/TAC 2018-2019 Renewal for Brown County employee's health benefits.
