A. Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding burn ban.

B. Lisa Dick, Administrator-Brownwood-Brown County Health Department-Update on COVID19 response and County health initiatives (Spon Pct. 2).

C. Joel Kelton, Commissioner Pct. 2-Discussion and possible action of speed limits on County Roads.
