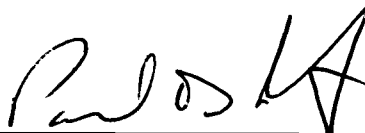

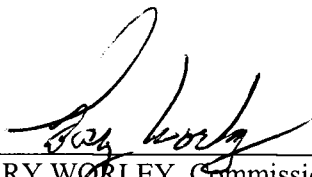

**AFFIDAVIT**

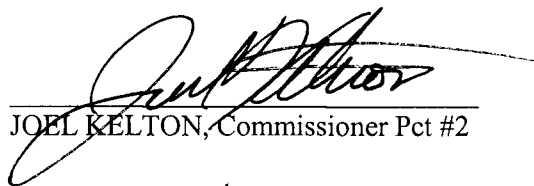

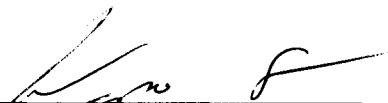

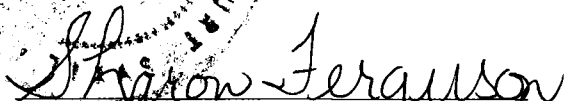
