**After discussion, with Justin P., from Black Plumbing, Commissioner Worley moved that the Court make a finding and declare an emergency, according to Local Government Code 262.024, to authorize added expenses to be made on the renovation of the Juvenile Detention Center/The Oaks. The funds will be paid from the Juvenile Justice Funds and the ARPA Funds. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. ([Exhibit #2](#))**
