



AFFIDAVIT





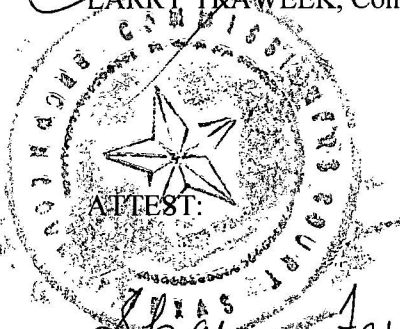
