

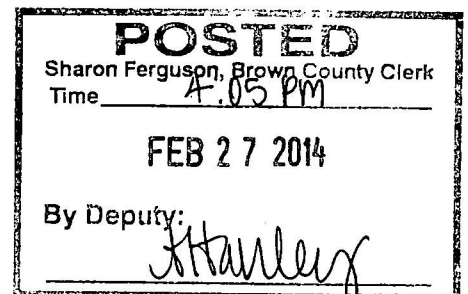

The Brown County Commissioners Court convened in a Special Session on March 3, 2014 at 9:00 A.M. in the Commissioner's Courtroom, Brown County Courthouse, 200 South Broadway Brownwood, Texas. Judge West called the meeting to order.

A. Opening prayer. Leland Acker, Pastor of Grace Pointe Baptist Church, at Brownwood, Texas, led the Court in the invocation.

B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the February 18, 2014 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.

C. Recognition of visitors.

D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains in effect.

**Item #2: Becky Caffey-Review of jail population and jail inspection report. Becky Caffey, Brown County Jail Administrator, and Sheriff Bobby Grubbs, presented the Texas Commission On Jail Standards Annual Jail Inspection Report, for filing. This certifies that the Brown County Jail has been inspected and has been found to be in compliance with the standards of the Texas Commission on Jail Standards. Sheriff Bobby Grubbs commended Becky Caffey, Brown County Jail Administrator, for diligently working in keeping the jail in compliance and presented her with the certificate issued by the commission for meeting the required standards. The Court commended Mrs. Caffey and the jail staff for their good work.

Commissioner Kelton seconded the motion and the Court voted 4-0 to approve.

Item #4: Wayne Shaw, Pct 3-Consideration and possible approval of vehicle purchase. Commissioner Shaw moved that he be authorized to purchase a 2006 Toyota Tacoma 4 wheel drive 4 door pick-up, for \$19,500.00, from Mike Nichols, for use in Precinct #3. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.

Item #5: Jan Brown-Consideration and possible approval for promoting Amanda Bundick to Chief Deputy. No action.

Item #6: Mechail Cox-Consideration and possible approval of Proclamation declaring the week of March 3rd thru March 8th as "Severe Weather Awareness" Week. After discussion, with Mechail Cox, Emergency Management Coordinator, Judge West moved that the Court approve a Proclamation to proclaim March 2 through March 8, 2014 as Severe Weather Awareness Week in Brown County. Commissioner Shaw seconded the motion and the Court voted 5-0 to approve. (Exhibit #5)

Item #7: Suzy Young-Consideration and possible approval of replacement Central Counting Judge for the 2014 Joint Primary Election. After discussion with Suzy Young, Brown County Elections Administrator, Commissioner Traweek moved that the Court approve the temporary appointment of Barbara Shields as Central Counting Judge for the Joint Primary to be held March 4, 2014. Commissioner Kelton seconded the motion and the Court voted 4-0 to approve. (Exhibit #6)

Item #8: Steve Ellis and Nita Richardson-Discussion of Indigent Defense Program and Pretrial Services for Brown and Mills Counties.

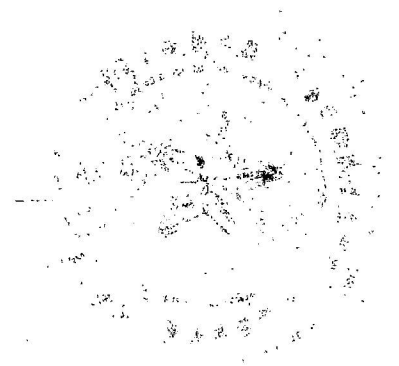
