- B. Reading and approval of minutes. Commissioner Worley moved that the minutes of the March 17, 2014 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Kelton seconded the motion and the Court voted 3-0 to approve.**

This item was tabled until March 27, 2014 at 10:00 A.M.

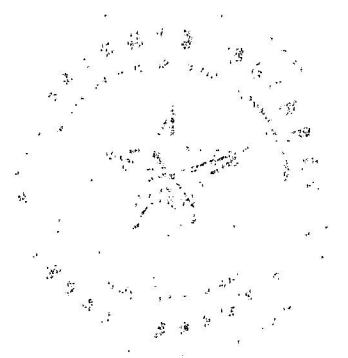
E. Reports. The March 24, 2014 Combined Statement of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #4)
