

- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the April 14, 2014 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken.

Commissioner Kelton moved that the Court approve a Resolution And Order Approving The County Transportation Infrastructure Fund Grant Program Agreement Designating Authorized Representative And Making Specific Findings Required By The Texas Department Of Transportation.
