B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the May 19, 2014 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Traweek seconded the motion and the Court voted 4 -0 to approve.

Item #1: David Phillips, Allegiance Ambulance, LLC: consideration and possible action to rescind Commissioners Court action on May 19, 2014; consideration and possible approval of proposed contract assignment to Allegiance Ambulance, and consideration and possible action on term of the assigned contract.

After discussion, Commissioner Kelton moved that the Court rescind the Commissioners Court action, taken on May 19, 2014 (Item #8 second paragraph): to authorize a new Agreement, between Brown County and Powell Professional of West Texas LLC d/b/a Guardian EMS, to Allegiance Ambulance, for three (3) years, effective the date that it is signed, and shall be subject to two (2) consecutive automatic five (5) year extensions to the term. Commissioner Worley seconded the motion to rescind and the Court voted 3-1 to approve with Commissioner Traweek voting nay. Ricky Powell, Chief Operating Officer of Allegiance Ambulance and CEO of Guardian EMS, David Furry, owner of Heart Of Texas EMS, and Ross Bradley, Guardian EMS addressed the Court. Commissioner Kelton moved that the Court accept an addendum, to the <u>existing</u> Agreement terms, between Brown County and Powell Professional of West Texas LLC d/b/a Guardian EMS, to Allegiance Ambulance, except as to the Consumer Price Index (CPI) Multiplier for purposes of increasing the subsidy. The subsidy is to remain the same and the Agreement expiration date will be December 31, 2015. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.

Item #2: Brown County Commissioners Court will meet jointly with the City Council of Brownwood to deliberate on the Agreement for Ambulance and Emergency Medical Services between Brown County and Allegiance Ambulance LLC.


Judge West stated that agenda Item #2 can be dispensed because deliberation has taken place.
