- A. Opening prayer. Leland Acker, Pastor of Grace Pointe Baptist Church, in Brownwood, Texas, led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the July 21, 2014 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Worley seconded the motion and the Court voted 4-0 to approve.
