Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Gary Worley, Pct 1-Consideration and possible approval of Agreement between Brown County and Oncor Electric Delivery Company, LLC for rehabilitation of CR 221 and CR 222.

Commissioner Traweek moved that the Court approve an Acknowledgment Of Payment And Release In Full agreement between Oncor Electric Delivery Company, LLC and Brown County for the rehabilitation of County Road #221 and County Road #222, in Precinct #1. Brown County will furnish all materials, water, equipment and labor for this project and Oncor will pay the specified amount of \$44,112.00. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve. (Exhibit #1)

Item #3: Ray West-Consideration and possible approval of appointment or reappointment of two members to Brown County Hospital Authority Board.

Commissioner Shaw moved that the Court approve the re-appointment of Keith Clark to serve as a Brown County representative on the Brown County Hospital Authority Board. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.

Commissioner Shaw moved that the Court approve the appointment of Paul Waldrop to serve as a Brown County representative on the Brown County Hospital Authority Board. Commissioner Kelton seconded the motion and the Court voted 4-0 to approve.
