The Brown County Commissioners Court convened in a Special Session on September 2, 2014 at 9:00 A.M. in the Commissioner's Courtroom, Brown County Courthouse, 200 South Broadway Brownwood, Texas. Judge West called the meeting to order. Members of the Court present were:

- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the August 25, 2014 meeting and the August 28, 2014 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.
 - C. Recognition of visitors.
- D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Sharon Ferguson, County Clerk- Consideration and possible approval of carpeting and painting for County Clerk's Office. Sharon Ferguson, Brown County Clerk, presented the Court with two estimates for the purchase and installation of new carpet in the County Clerk's Office. One estimate was from Jones Carpets and one estimate was from Brownwood Decorating. After discussion, Commissioner Kelton moved that the Court authorize the purchase and installation of new carpet in the County Clerk's Office and approve the lower of the two estimates, which is from Brownwood Decorating, for \$5,099.85. This expenditure will be paid from the County Clerk Records Management Fund. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. The Court did not consider the painting of the County Clerk's Office at this time.

Item #4: Bobby Duvall, Sheriff's Office-Consideration and possible approval of insurance deductible for key card access system.
