## Terms and Conditions of AZI Equipment Rental Agreement

- 1. Operators: Customer agrees that all operators of this Equipment shall be properly trained by a qualified AZI representative.
- 2. Use: Both Customer and AZI acknowledge that the use of the Zipper is for pulverizing Asphalt or Gravel Roads, Asphalt parking lots, Asphalt Drive ways, or other similar surfaces. Pulverizing of Concrete, Cobblestone or other surfaces is not approved. Customer understands that use in non approved applications may result in damage to the Zipper, which may result in loss of damage deposit and additional monies being owed to Asphalt Zipper.
- 3. Examination of Zipper: Customer understands that after the conclusion of the Rental AZI will perform an examination of the Zipper. Customer will be responsible for the repair of non-wear items, normal wear and tear excepted. The Customer damage deposit will be used for reimbursement of the cost of repairs, if any. If additional monies are required, the customer agrees to provide such monies to AZI upon billing.
- 4. Use of Rental Fee towards purchase. AZI hereby provides to the customer the opportunity to apply the Rental fee, and refundable damage deposit if applicable, toward the purchase of the Rental Zipper with the following conditions:
  - A. Purchase of the rental Asphalt Zipper. 100% of the Rental fee will be applied towards the purchase if the customer takes delivery and purchases the Rental Asphalt Zipper at the conclusion of the Rental agreement.
  - B. Purchase of a different Asphalt Zipper within 30 days of the conclusion of the rental agreement. If the customer returns the Rental Asphalt Zipper back to Asphalt Zipper, Inc., and within 30 days of the return elects to purchase another Asphalt Zipper, then 35% of the rental fees billed will be applied towards the purchase of a different Asphalt Zipper. If the Asphalt Zipper that was rented has sustained damage by the customer that is beyond the amount of the damage deposit, the amount of the additional damage will be deducted from

the amount of rented funds allowed to be pledged towards the purchase of another Asphalt Zipper.

- C. Purchase of a different Zipper after 30 days of the conclusion of the rental agreement and within 120 days of the conclusion of the rental agreement. If the customer returns the Zipper back to Asphalt Zipper, Inc., and after 30 days of the return but prior to 120 days from the conclusion of the rental agreement, elects to purchase another Asphalt Zipper, then 25 % of the rental fees billed will be applied towards the purchase of a different Asphalt Zipper. If the Asphalt Zipper that was rented has sustained damage by the customer that is beyond the amount of the damage deposit, the amount of the additional damage will be deducted from the amount of rented funds allowed to be pledged towards the purchase of another Asphalt Zipper.
- 5. Indemnification: Customer shall indemnify and hold AZI and AZI representative(s) harmless from any and all claims, actions, proceedings, expenses, damages, costs and liabilities arising in connection with the Equipment including, without limitation, its selection, purchase, manufacture, delivery, possession, use operation or return and from any injury to property or to life caused in any way by the Equipment during the agreement term or any extensions thereof.
- 6. Location of Operation of Equipment: It is agreed that the Customer assumes total and complete responsibility to locate and expose all buried utilities and that the Customer will bear the full financial burden of any and all expense associated with or arising from the repair of any damaged utilities at the selected site of operations, no matter what the nature or irrespective of how the damage occurred. It is further agreed that the Customer assumes total and complete responsibility to bear the full financial burden of all expenses associated with any environmental or structural damage, no matter what the nature, or irrespective of how the damage occurred, at the site of operations. The Customer agrees that the Equipment shall not be used in violation of any federal, state or municipal statute, order or regulation.
- 7. Insurance: Customer warrants that during the term of this agreement, Customer's Insurance includes the following coverage on a primary and non contributory basis:
  - A. Business auto liability insurance: \$1,000,000 per occurrence
  - B. Statutory Worker Compensation Insurance
  - C. Commercial general liability insurance: \$1,000,000 per occurrence, \$1,000,000 aggregate.
  - D. Further, Customer agrees that upon written request from AZI, customer will provide a certificate of insurance naming AZI as an additional insured.
- Miscellaneous. This agreement contains all of the covenants between the parties hereto
  and any representation or understanding not contained here in shall be of no force or
  affect whatsoever.
