I would like to bring to your attention that a misprint was discovered in the coverage proposal we mailed to you this week. We accidentally referenced the incorrect year with regards to the multi-line discount applied to your 2014 Workers' Compensation coverage.

The Workers' Compensation Proposal page and the Exceptions page both have the below statement:

"Brown County received a multi-line discount of \$12,091 on the January 1, 2015 Workers' Compensation coverage."

This statement should reference 2014, not 2015. When the county renews their Workers' Compensation coverage with the pool, and if all coverage remains in place with the pool, Brown County will again receive a multi-line discount.
