



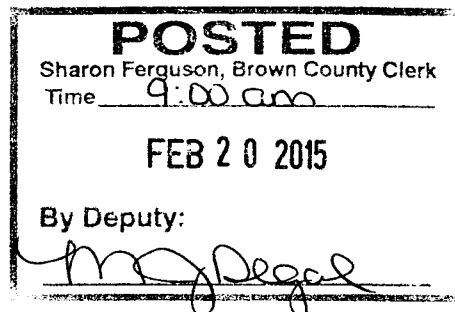

- A. Opening prayer. Rick Phelps led the Court in the invocation.**
- B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the February 9, 2015 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.**

**Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.**

**Item #2: VFW Post 3278/Ladies Auxiliary-Presentation of Corp Tevan Nguyen, US Marine Corps, picture to his family. Joyce Leidig, representing the Ladies Auxiliary, read a tribute and made a presentation to Tam and Amy Nguyen, the parents of Corporal Tevan Nguyen, a United States Marine, who was killed in action December 28, 2010. The family was presented flowers, a teddy bear, and a framed photo commemorating their son.**
