OVERVIEW AND PROJECT UNDERSTANDING

SECTION 2: PROJECT APPROACH/SCOPE OF WORK

Emergency Medical Services (EMS) and other transportation systems are complex organizations that combine features of medical practice, healthcare management, community service, production and distribution, sophisticated technology, and healthcare finance. Each EMS system design contains many interrelated components.

As a result, changes made to any part of the system are likely to affect other system components. Therefore, it is important to fully understand the current system environment, design, assets and resources, including which components work well and which are in need of improvement, before comprehensive recommendations can be safely prescribed.

This project will result in Health Care Visions initially providing a system evaluation, gathering data and information to assist in the procurement and RFP development.

Health Care Visions anticipates the following scope of services, steps, and timelines for the project.

Phase 1 – System Evaluation

- 4. Collect and evaluate all other relevant data.
- 5. Formulate a series of ambulance delivery options, complete with an analysis of relative operational and financial strengths and weaknesses for review by the County and/or its representatives.

Phase 2 - RFP Development and Procurement Process

Scope of Services - Timelines

1. Using the data and information gathered in Phase 1, develop and seek approval of a request for proposals (RFP) to be advertised and released for EMS and ambulance services. *Approximate RFP release June 15, 2015.*



- 2. Advertise, hold and facilitate a bidders' conference; providing all interested parties an opportunity to clarify any questions or concerns about the RFP. *Approximate date July 1, 2015.*
- 3. Assist in the development of a selection committee to evaluate the proposals. *Approximate date, July 1, 2015.*
- 4. Receive, evaluate and begin scoring the proposals through the use of the selection committee. *Approximate date August 10, 2015*.
- 5. Provide recommendation for a qualified service provider to the County, moving through County approval process. *Approximate date August 24, 2015.*
- 6. After approval process begin negotiations with recommended provider, finalizing contract. *Approximate date October 1, 2015*.
- 7. Monitor transition process until start date of January 1, 2016
- 8. Provide 90 day assessment to the County of new provider start-up progress. *March 31, 2016*

CONSULTING AGREEMENT

THIS AGREEMENT is made by and between **Brown** ("Client") and Health Care Visions ("Consultant").

WHEREAS, it is the desire of Client to engage Consultant to perform certain consulting services in the field of emergency medical services and related areas on Client's behalf; and,

WHEREAS, it is the desire of the Consultant to undertake for Client such services on the terms and conditions as set forth herein.

NOW THEREFORE, in consideration of the mutual promises contained in this agreement and for other good and valuable consideration the receipt and sufficiency of which is acknowledged, the parties agree as follows:

- 1. <u>Services.</u> Consultant will provide general consulting services, as described in the proposal titled "Health Care Visions, Proposal for Brown County EMS System RFP Development and Provider Selection, April 2015"
- 2. <u>Term.</u> The respective duties and obligations of the parties to this agreement shall be for a period of 1 year or until the project identified herein is completed, if earlier. The Client may terminate this agreement without cause upon thirty (30) days written notice to Health Care Visions.
- 3. <u>Compensation.</u> For the services to be rendered under this agreement the Client shall pay to Consultant \$20,000 payable 1/3 upon contract execution and 1/3 payable upon the release of the RFP and the final 1/3 payable upon an execution of an agreement with the selected ambulance provider.
 - Client shall reimburse Consultant for all reasonable expenses incurred in connection with the performance of the services to be rendered hereunder. Such expenses shall include, travel, hotel, meals, auto rental or mile reimbursement, printing and design services, audiovisual rental, video production/post production, electronic distribution of news releases, clipping services, advertisement placement and the like. All expenses are charged at cost without markup. Consultant shall not incur any single expense item in excess of \$500 without the prior approval of Client. Total project expenses will not exceed \$5,000.
- 4. <u>Nondisclosure</u>. Consultant will not disclose any confidential information including, without limitations the purpose of this agreement or trade secrets of Client, regardless of whether the confidential information or trade secrets have been conceived or developed, in whole or in part, by the efforts or investment of Client or by others.

The terms "confidential information" and "trade secrets" as used in this Agreement shall include, without limitation, the whole or any portion of confidential methods

and specialized techniques of the business operations of Client and any other information concerning the business or affairs of Client, which is of a confidential character and which has not been published or otherwise become a matter of general public knowledge. Consultant will not breach this covenant by making any disclosure that is required by law.

- 5. <u>Intellectual Property.</u> The Client shall be entitled to the fair use of any intellectual property rights associated with the rendition of the services but Consultant retains all other rights and privileges with respect to all intellectual property created in connection with or arising out of this Agreement and the services to be rendered hereunder.
- 6. <u>Mediation</u>. If any dispute arises between the parties out of or connected with this Agreement or the rights and duties of the parties as set forth herein on contemplated hereby, then the parties agree any such dispute, shall be submitted for nonbinding mediation before the American Arbitration Association prior to commencement of litigation.
- 7. Independent Contractor. Consultant shall be deemed an independent contractor of Client and nothing in this Agreement shall be construed to create an employment, partnership, or joint venture relationship between the parties.
- 8. <u>Assignment.</u> Neither party shall have the right to assign any of his rights or obligations under this Agreement, in whole or in part, without the written consent of the other party.
- 9. <u>Limitation on Damages.</u> Client agrees that Consultant will not be liable for Client's lost profits or other consequential damages of any kind in the event of a breach of this Agreement or other liability arising out of the services to be performed hereunder.
- 10. <u>Amendment, Waiver, Entire Agreement</u>. No amendment hereof shall be deemed valid unless set forth in writing signed by both parties. Waiver of any provision of this Agreement will not have any effect on any part of the remainder of the Agreement nor will it be construed as a waiver of that or any other provision in the future nor will it be deemed a waiver of any subsequent breach of a provision of the Agreement.

This Agreement constitutes the entire agreement of the parties and supersedes and cancels all prior oral or written understandings or agreements. Time is of the essence in this Agreement. All amounts due under this Agreement and remaining unpaid for 20 days shall bear interest at the lesser of eighteen percent per annum or the maximum rate permitted by applicable law.

11. <u>Notices.</u> Any notices from one party to the other party shall be deemed valid and effective, if and only if it is in writing and is delivered by way of certified mail return receipt requested, registered mail, or nationally recognized delivery service providing

proof of delivery, and, furthermore, is delivered to the party receiving the notice at the address of the party set forth below, whether or not the notice is accepted.

Each provision of this Agreement is intended to be severable from the others only to the extent that if any provision or term hereof is determined to be illegal or invalid for any reason whatsoever (and cannot be modified or interpreted by a court or arbitrator to be enforceable), such illegality or invalidity shall not affect the validity of the other provisions and terms hereof:
- 15. <u>Enforceability</u>. This Agreement and any amendments hereto shall be governed by and construed in accordance with the laws of the State of Texas (except for its choice of law provisions).
- 16. <u>HIPAA Compliance</u> Health Care Visions shall carry out its obligations under this Agreement in compliance with the privacy regulations pursuant to Public Law 104-191 of August 21, 1996, known as the Health Insurance Portability and Accountability Act of 1996, Subtitle F Administrative Simplification, Sections 261, et seq., as amended ("HIPAA"), to protect the privacy of any personally identifiable protected health information ("PHI") that is collected, processed or learned as a result of the services provided in Brown County, Texas, by Health Care Visions.
