

STATE OF TEXAS COUNTY OF BROWN

The Brown County Commissioners Court convened in a Special Session on June 1, 2015 at 9:00 A.M. in the Commissioner's Courtroom, Brown County Courthouse, 200 South Broadway Brownwood, Texas. Judge West called the meeting to order. Members of the Court present were:

- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the May 18, 2015 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve.
 - C. Recognition of visitors.
- D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Joel Kelton, Pct 2-Public Hearing-Discussion of posting of a 35 mph speed limit on a portion of CR 120 between two cattle guards. Judge West asked for public comment regarding the proposed 35 mph speed limit on a portion of County Road #120 between two cattle guards. After discussion, there were no public comments. (Exhibit #1)

Item #3: Joel Kelton, Pct 2-Consideration and possible approval of posting of a 35 mph speed limit on a portion of CR 120 between two cattle guards. Commissioner Kelton moved that the Court authorize a 35 mph speed limit on a portion of County Road #120, off Hwy 279 heading east at the beginning of County Road #120 for 5/10 of a mile to the second cattle guard. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve.

Item #4: Ray West, County Judge-Consideration and possible approval of fireworks ban. No action.

Item #5: Becky Caffey, Jail Administrator-Consideration and possible approval for discretionary exemptions under 262.024 of the Texas Government Code for food bids. After discussion, with Jail Administrator Becky Caffey, Judge West moved that the Commissioner's Court order that the purchase of all food items, for the jail, shall be exempt from the requirement of sealed bids pursuant to the Texas Local Government Code 262.024 (a)(8) as to the requirements set out in Section 262.023 of the Texas Local Government Code. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.

Item #6: Sheriff's Office-Employee changes. Commissioner
Traweek moved that the Court approve the following personnel

Commissioner Kelton seconded the motion and the Court voted 3-0 to approve.

Item #7: Joel Kelton, Pct 2-Consideration and possible approval of part time employee. Commissioner Kelton moved that the Court approve the part-time temporary employment of Donnie Graves to work as a road hand for Precinct #2, effective May 26, 2015. Mr. Graves will be paid \$11.50 per hour not to exceed 29 hours per week. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve. (Exhibit #3)

Item #8: Joel Kelton, Pct 2-Consideration and possible approval to ratify the decision of the Brown County Elections Commission.

After discussion, Commissioner Shaw moved that the Court accept the letter of resignation from Elections Administrator Suzy Young, effective June 16, 2015. Commissioner Traweek seconded the motion and the Court voted 3-1 to approve. Commissioner Kelton voted nay.

After discussion, Judge West moved that the Court not ratify the decision of the Brown County Elections Commission and accept the letter of resignation from Elections Administrator Suzy Young, effective June 16, 2015. Commissioner Shaw seconded the motion and the Court voted 3-1 to approve. Commissioner Kelton voted nay. (Exhibit #4)

Item #9: Wayne Shaw-Pct 3-Consideration and possible approval of vehicle purchase. Commissioner Shaw moved that the Court authorize him to purchase a 2014 Ford half ton F150 crew cab pickup, for \$21,771.34, from Equipment & Transportation. Commissioner Traweek seconded the motion and the Court voted 3-0 to approve. (Exhibit #5)
