B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the June 1, 2015 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Traweek $GhA\omega$ seconded the motion and the Court voted 3-0 to approve.

C. Recognition of visitors.

D. Matter of new business to be presented to the Court for

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Nina Cox, County Auditor & Matt Krischke, IT Manager-Consideration and possible approval of internet upgrade. After discussion, with County Auditor Nina Cox and IT Manager Matt Krischke, Commissioner Kelton moved that the Court approve an internet lease agreement, between MCI Communications Services, Inc. d/b/a Verizon Business Services and Brown County, for a fiber optic dedicated internet line to the courthouse and to the Law Enforcement Center.
