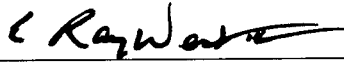

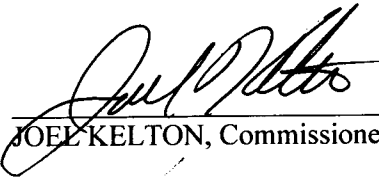
AFFIDAVIT

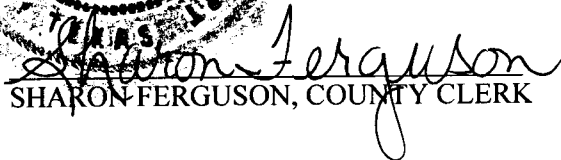
