B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the September 28, 2015 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve.

C. Recognition of visitors.
