

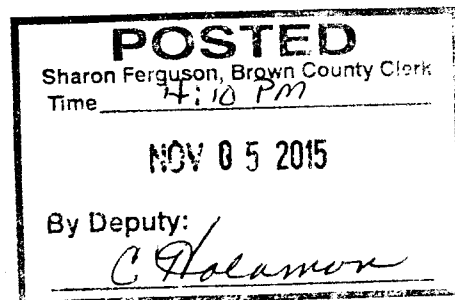

**The Brown County Commissioners Court convened in a Regular Session on November 9, 2015 at 9:00 A.M. in the Commissioner's Courtroom, Brown County Courthouse, 200 South Broadway Brownwood, Texas. Judge West called the meeting to order. Members of the Court present were:**

- A. Opening prayer. Lisa Tipton led the Court in the invocation.**
- B. Reading and approval of minutes. Commissioner Shaw moved that the minutes of the November 2, 2015 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.**
- C. Recognition of visitors.**

**Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.**

**Item #2: Joel Kelton, Pct 2-Consideration and possible approval of contract for LifeGuard, Inc. for ambulance services. After discussion, with Steve L. Athey, EMS consultant with Health Care Visions, Commissioner Kelton moved that the County approve a Contract for Exclusive Ambulance Service between Brown County and Lifeguard Ambulance Service of Texas, LLC. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #1)**

**Item #3: Ray West, County Judge-Consideration and possible approval of County Holidays for 2016. Commissioner Traweek moved that the Court adopt the Proposed Holidays for Calendar Year 2016, as listed in Exhibit #2 to these minutes. Commissioner Kelton seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)**

**Item #4: Sheriff's Office-Employee changes. Commissioner Worley moved that the Court authorize the following personnel changes at the Sheriff's Department:**

**Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.**

**Item #5: Sheriff's Office-Recognition of Valton Posey for 35 years of service. Sheriff George Caldwell and Captain Vance Hill presented Deputy Valton Posey with a plaque of appreciation, and from employees an engraved nameplate, a pin, and an engraved garment bag, and thanked him for over 35 years of service and for his commitment and dedication to the Brown County Sheriff's Office and the citizens of Brown County.**

**Item #6: Nina Cox, County Auditor-Consideration and possible approval of Resolution authorizing the publication of notice of the issuance of Certificates of Obligation to finance the capital renovations, remodeling and improvements to County buildings and the construction of a new building (McKinstry project). Commissioner Traweek moved that the Court approve a Certificate For Resolution directing publication of notice of intention to issue certificates of obligation to finance the capital renovations, remodeling and improvements to County buildings and the construction of a new building.
