The Brown County Commissioners Court convened in a Regular Session on April 11, 2016 at 9:00 A.M. in the Commissioner's Courtroom, Brown County Courthouse, 200 South Broadway Brownwood, Texas. Judge Pro-Tem Kelton called the meeting to order. Members of the Court present were:

- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the April 4, 2016 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.
 - C. Recognition of visitors.
- D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Sherry Clark, Brown County Child Welfare Board-Consideration and possible approval of member(s) to child Welfare Board. Commissioner Worley moved that the Court approve the appointment of Jill Evans to serve on the Child Welfare Board of Brown County, as presented by Chair Sherry Clark. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #1)

Item #3: Wayne Shaw, Pct 3-Consideration and possible approval of equipment trade. Commissioner Shaw moved that he be authorized to trade a Pre-Owned CAT Motor Grader for a Hamm 2420D Single Drum Roller, 1E Mini Excavator, 2006 Eager Beaver 20XPT Trailer, and a 2006 Davis PDT 12-17 Pup Trailer, from Centex Equipment Sales, for use in Precinct #3. This is an even trade, no monetary exchange. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)

Item #4: Wayne Shaw, Pct 3-Application to install private line, CR 294. Commissioner Shaw moved that the Court approve an application, made by Zephyr Water Supply, to install a buried line within the right-of-way of County Road #294, in Precinct #3; subject to Brown County specifications for cutting a road. Commissioner Kelton seconded the motion and the Court voted 4-0 to approve. (Exhibit #3)

Item #5: Tony Aaron, Administrator-City of Early-Consideration and possible approval of Interlocal Agreement between City of Early and Brown County regarding street repair project. Commissioner Shaw moved that the Court approve an Interlocal Agreement, and an Approval Of Project, between Brown County and the City of Early for the County to furnish labor and equipment and for the City of Early to assume the cost of materials, not to exceed \$6,000.00, for seal coating and overcoat on approximately 3/10 mile down Jenkins Springs Road/County Road 262, in Precinct #3. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.
