



- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the April 25, 2016 meeting be approved, as presented by Chief Deputy County Clerk Carol Holamon. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.
  - C. Recognition of visitors.
- D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Vance Hill, Capt. Sheriff's Office-Discussion of issues with the in car patrol videos and possible approval to replace the equipment. After discussion, with Chief Deputy Sheriff Vance Hill, Commissioner Worley moved that the Court authorize the Sheriff's Department to purchase six (6) in car patrol video cameras, from Watch Guard. The purchase price, of \$29,520.00, will be paid from the Non-Departmental Contingency Line Item (General Fund). Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. Item #3: Cheryl Jones, District Clerk-Consideration and possible approval of Brown County Jury Plan. After discussion, with District Clerk Cheryl Jones, Commissioner Traweek moved that the Court approve the Jury Selection Plan for Brown County, Texas. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)

Commissioner Worley moved that the Court adopt a Resolution to approve the Brown County Jury Selection Plan. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #3)

Item #4: Ron Dority-Consideration and possible approval to install a cattle guard, CR 137. After discussion, with Ron Dority, no action was taken.
