TO THE COMMISSIONER'S COURT OF Brown County,

ATTENTION COUNTY JUDGE:

Formal notice is hereby given that Frontier Communications will construct a communication line within the right-of-way of a County Road in Brown County, Texas __ as follows:

Starting 4000ft West of Hwy 283 N on County Road 476 in the South right of way Frontier Communications proposes to place 1 pole, and 1 pedestal, then place 225ft of aerial copper cable heading West in the south ROW, then place 1 pedestal, and one pole, ending 4225ft West of Hwy 183 N within 5ft of the South ROW. This work will include the placing of two poles, two pedestals, and 225ft of aerial copper cable. The new aerial cable will maintain a minimum overhead clearance of 15ft 5in. The Row will be returned to as good or better condition. This aerial cable is being placed to replace a buried cable that has been damaged by county workers maintaining County Road 476, at a low water crossing.

The location and description of this line and associated appurtenances is more fully shown by

1 copies of drawings attached to this notice. The line will be constructed and maintained on the County Road right-of-way in accordance with governing laws.

Notwithstanding any other provisions contained herein, it is expressly understood that tender of this Notice by Frontier Communications does not constitute a waiver, surrender, abandonment or impairment of any property rights, franchise, easement, license, authority, permission, privilege or right now granted by law or may be granted in the future and any provision or provisions so construed shall be null and void.

Construction of this line will begin on or after July 5, 2016.


