

- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Shaw moved that the minutes of the June 20, 2016 and the June 27, 2016 meetings be approved, as presented by County Clerk Sharon Ferguson. Commissioner Traweek seconded the motion and the Court voted 3-0 to approve.
 - C. Recognition of visitors.
- D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.

Item #1: Joel Kelton, Pct 2-Considertion and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Carl Greer, Maintenance Supervisor-Consideration and possible approval of purchase of new fire alarm system for courthouse. After discussion, with Courthouse Maintenance Supervisor Carl Greer, Judge West moved that the Court authorize Inca-Trio Fire Services, LP to furnish, install, and program a new Silent Knight 5208 fire alarm control panel for \$2,025.00, for the Courthouse, to be paid from the Courthouse Maintenance Fund. Commissioner Kelton seconded the motion and the Court voted 4-0 to approve. (Exhibit #1)

Item #3: Bart Johnson-Consideration and possible approval for Texas Association of Counties health insurance. After discussion, with Bart Johnson, from Painter and Johnson Financial, no action was taken. (Exhibit #2)

Item #4: Ray West, County Judge-Consideration and possible approval to reappoint Shane Britton as a member of the Board of Trustees of Central Texas Mental Health Mental Retardation dba Center for Life Resources. Judge West moved that the Court approve the re-appointment of Shane Britton to serve on The Center For Life Resources board of trustees. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #3)

Item #6: Vance Hill, Chief Deputy-Consideration and possible approval to purchase remainder of patrol car video systems from Watch Guard. After discussion, with Chief Deputy Sheriff Vance Hill, Commissioner Traweek moved that the Court authorize the Sherrif's Department to purchase six (6) additional in car patrol video camera, from Watch Guard. Six in car patrol video cameras were approved for purchase at the May 2, 2016 meeting. The purchase price, of \$29,370.00, will be paid from the County Equipment Fund. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #5)

Item #7: Vance Hill, Chief Deputy-Consideration and possible approval to accept donations. Chief Deputy Sheriff Vance Hill informed the Court that the Sheriff's Department has received a \$5,000.00 donation from Cross Cut resident Mrs. Wood. This contribution is in recognition of the Sheriff Department's service to others and will be deposited in the Sheriff Department's Contribution Fund0. Commissioner Kelton moved that the Court authorize the acceptance of the donation to the Sheriff's Department. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve.
