- B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the July 11, 2016 and July 18, 2016 meetings be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. Commissioner Worley abstained from voting on the July 11, 2016 minutes.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains in effect.

Item #3: Karen Opiela, Elections Administrator-Consideration and possible approval of personnel changes. After discussion, with Elections Administrator Karen Opiela, Commissioner Traweek moved that the Court approve the temporary part-time employment of Ervin Bates, effective 07-28-2016. He will be working approximately 27 hours per week and will be paid \$10.58 per hour. Commissioner Kelton seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)

Item #4: Sherry Clark, Child Welfare Board-Consideration and possible approval of new board member. Commissioner Shaw moved that the Court approve the appointment of Jacqueline Rider to serve as a member on the Child Welfare Board of Brown County, as presented by Chair Sherry Clark. Commissioner Kelton seconded the motion and the Court voted 4-0 to approve. (Exhibit #3)

Item #5: Ann Krpoun, Treasurer-Consideration and possible approval of health insurance proposal from TAC for FYI 2016-2017. After discussion, with County Treasurer Ann Krpoun, Commissioner Kelton moved that the Court approve the Texas Association of Counties Health and Employee Benefits Pool 2016/2017 Renewal Notice and Benefit Confirmation Medical Plan 700. The plan will run the fiscal year instead of the calendar year. Commissioner Worley seconded the motion and the Court voted 4-0 to approve. (Exhibit #4)
