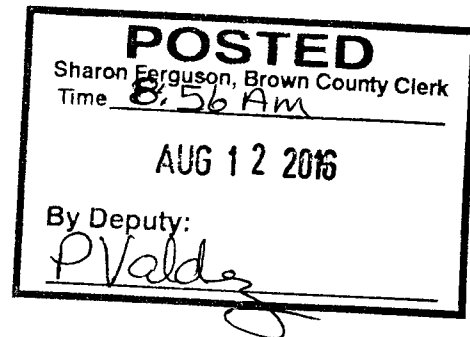

- A. Opening prayer. Rick Phelps led the Court in the invocation.**
- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the August 1, 2016 and the August 8, 2016 meetings be approved, as presented by County Clerk Sharon Ferguson. Commissioner Worley seconded the motion and the Court voted 4-0 to approve.**
- C. Recognition of visitors.**

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains in effect.

Item #2: Larry Traweek, Pct 4-Application to install private line, CR 574. Commissioner Traweek moved that the Court approve an application, made by Brookesmith SUD, to install a buried water line within the right-of-way of County Road #574, in Precinct #4; subject to Brown County specifications for boring a road. Commissioner Worley seconded the motion and the Court voted 4-0 to approve. (Exhibit #1)

Item #3: Larry Traweek, Pct 4-Application to install private line, CR 105. Commissioner Traweek moved that the Court approve an application, made by Brookesmith SUD, to install a buried water line within the right-of-way of County Road #105, in Precinct #4; subject to Brown County specifications. Commissioner Worley seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)

Item #4: Karen Opiela, Elections Administrator-Order the November 8th General Election. Larry Franks, Assistant Elections Administrator, presented the Order Of General Election, for November 8, 2016, for Judge's signature. (Exhibit #3)

Item #5: Karen Opiela, Elections Administrator-Consideration and possible approval of election Precinct Judges and Alternate Judges for a one year term beginning September 1, 2016. After discussion, with Assistant Elections Administrator Larry Franks, Commissioner Kelton moved that the Court approve the List Of Presiding And Alternate Judges, for a one year term beginning September 1, 2016, as submitted. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #4)
