- A. Opening prayer. Leland Acker led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the August 29, 2016 and the September 1, 2016 meetings be approved, as presented by Chief Deputy County Clerk Carol Holamon. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Ray West, County Judge-Public hearing on proposed tax rate. Judge West opened the 1<sup>st</sup> Public Hearing, on the proposed tax rate, for public comment or questions. Comments were made from Tommy Blevins, David Carroll, and Jessica Acker opposing the proposed tax rate. After discussion, Judge West recessed the first public hearing.

Item #3: Gary Worley, Pct 1-Considertion and possible approval to rescind motions from Commissioners Court 7/25/16 and 8/22/16 concerning truck purchase for Precinct 1. Commissioner Worley moved that the Court rescind the motion he made, on July 25, 2016, to purchase a 2011 Mack Truck, through the Buy Board process, from Bruckner Truck Sales, Inc. for \$65,568.00 and also to rescind the motion he made, on August 22, 2016, to purchase a 2011 Mack dump truck, from Bruckner Truck Sales, Inc., through the Buy Board process, for the corrected purchase price of \$65,968.00. Commissioner Shaw seconded the motion to rescind and the Court voted 4-0 to approve.

Item #4: Gary Worley, Pct 1-Consideration and possible approval to seek bids for dump truck. Commissioner Worley moved that he be authorized to seek bids for a used 2011, or newer, dump truck, for use in Precinct #1. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.

Item #5: Gary Worley, Pct 1-Consideration and possible approval of Resolution for opposition to Appraisal caps and Revenue caps. Commissioner Worley moved that the Court adopt a Resolution for Opposition to Appraisal Caps and Revenue Caps upon Texas counties. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. Commissioner Kelton abstained. (Exhibit #1)

Item #6: Gary Worley, Pct 1-Consideration and possible approval of Resolution for opposition to unfunded mandates. Commissioner Worley moved that the Court adopt a Resolution for Opposition to Unfunded Mandates by supporting the passage of legislation in the form of an amendment to the Constitution of the State of Texas that would prohibit the imposition of a mandatory governmental program on Texas counties. Commissioner Kelton seconded the motion and the Court voted 5-0 to approve. (Exhibit #2)

Item #7: Gary Worley, Pct 1-Consideration and possible approval for Resolution for state funds for Indigent Criminal Defense. Commissioner Worley moved that the Court adopt a Resolution requesting that the Texas Legislature fully fund the costs of indigent criminal defense. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve. (Exhibit #3)

Item #8: Sharon Ferguson, County Clerk-Consideration and possible approval of two bonds for Tax Assessor Collector.

Commission Shaw moved that the Court approve the County bond, for Tax Assessor Collector Christine Pentecost, as presented by Chief Deputy County Clerk Carol Holamon. Commissioner Traweek seconded the motion and the Court voted 5-0 to approve. (Exhibit #4)
