Approximately 70% of the receipts will be realized through a proposed ad valorem tax of .6093 cents per \$100 of assessed valuation. The remainder of the receipts will come from other local sources, fund balances, and state payments.

**WHEREAS**, The Brown County Commissioners Court met in a Special Meeting of the Commissioners Court, open to the public, on September 26, 2016 to adopt the 2016 tax rate for the fiscal year of 2016-2017; and

**BROWN COUNTY PROPERTY TAXES WILL BE INCREASED BY THE ADOPTION OF A TOTAL TAX RATE OF 0.6093.**



**THIS TAX RATE WILL EFFECTIVELY RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S RATE BY 4.64%. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 4.64% AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$13.80. This year's levy to fund maintenance and operations expenditures exceeds last year's maintenance and operations tax levy.**

**NOW, THEREFORE**, the Brown County Commissioners Court does hereby adopt the above stated tax rate

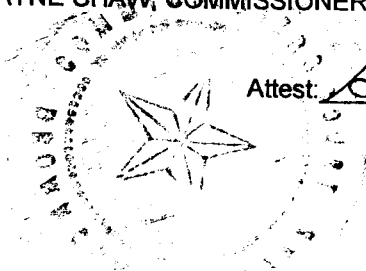
