- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the November 14, 2016 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 3-0 to approve.
 - C. Recognition of visitors.
- D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Elections Administrator-Canvass of the November, 2016 General Election. Judge West, and the Commissioners Court, sat as the canvassing board to canvass the General Election held on November 8, 2016. After discussion, with Brown County Elections Administrator Karen Opiela, Judge West moved that the Court certify that the tabulation of returns is true and correct as shown by the attached Canvass Report tabulated and printed from the Hart Voting System Tally program used for processing the electronic voting media on Election Night for the General Election. After discussion, with County Auditor Jennifer Robison, Commissioner Kelton moved that the Court declare as surplus, to be disposed of, a printer, a scanner, and a keyboard. Item #4: Ray West, County Judge-Consideration and possible approval to reappoint David Olhausen to the Cen-Tex Rural Rail Transportation District for two year term for the years 2017 and 2018. Judge West moved that the Court approve the re-appointment of David Olhausen, for a two-year term for the years 2017 and 2018, as the director, from Brown County, for the Cen-Tex Rural Rail Transportation District. Item #6: Ray West, County Judge-Consideration and possible approval of part time fill in employees for Brown County Court Administrator. Judge West moved that the Court authorize him to hire Sharon Early and Diane Day, as port-time temporary employees, for the County Judge's Office, based on availability, when the County Judge's Administrator is not available. Commissioner Worley seconded the motion and the Court voted 5-0 to approve.
