Item #5: Micheal Murray, District Attorney-Presentation regarding software and related equipment that the District Attorney's office will be purchasing. District Attorney Micheal Murray and Assistant District Attorney Elisha Bird presented information, to the Court, regarding the need for purchasing software and equipment needed for the District Attorney to be in compliance with the "Michael Morton Act".
