- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the April 10, 2017 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Wayne Shaw, Pct 3-Public Hearing regarding reducing speed limit on a portion of C.C. Woodson. Judge West asked for comments, from the audience, concerning a proposed 35 mph speed limit on a portion of C.C. Woodson, between the City Limits of Early and the City Limits of Early, in Precinct #3. Item #3: Wayne Shaw, Pct 3-Consideration and possible approval of reduced speed limit on a portion of C.C. Woodson. Commissioner Shaw moved that the Court establish a School Zone on the County portion of CC Woodson road (from the Early City Limits West to the Brownwood City Limits) thereby lowering the Speed Limit from 45 mph to 35 mph twice daily (from 7:30 A.M. to 8:30 A.M. and 2:30 P.M. to 4:00 P.M.) when School Zone lights are flashing. Commissioner Worley seconded the motion and the Court voted 4-0 to approve.

Item #4: Wayne Shaw, Pct 3-Consideration and possible approval to install private line. Commissioner Shaw moved that the Court approve an application, made by Zephyr Water Supply Corporation, to install a buried line within the right-of-way of County Road #261, in Precinct #3; subject to Brown County specifications for cutting a road. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)

Item #5: Gary Worley, Pct 1-Consideration and possible approval to install private line. Commissioner Worley moved that the Court approve an application, made by CZ Fabricators, to install a buried/aerial communication line within the right-of-way of County Road #225, in Precinct #1; subject to Brown County specifications for boring a road. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #3)
