- B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the May 8, 2017 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Wayne Shaw, Pct 3-Consideration and possible approval to declare vehicle/equipment as surplus. After discussion, Commissioner Shaw moved that the Court declare a 2012 Ford van and a Kubota tractor, from Precinct #3, as surplus. This travel will primarily be funded from Chapter 19 funds which come from the Secretary of State's (SOS) Office through reimbursement.
