- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the July 3, 2017 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Worley seconded the motion and the Court voted 3-0 to approve.
  - C. Recognition of visitors.
- D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, Commissioner Worley moved that the Court lift the burn ban. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.

Item #2: Steve Ellis, District Judge-Introduction of newly appointed Court Reporter for the 35<sup>th</sup> Judicial Court Judge.

Bart Johnson, Brown County Agent of Record, from Painter And Johnson Financial, and Kathy Davenport, Employee Benefits Consultant, from TAC, discussed with the Court the renewal of the Brown County Employee health insurance.
