



Texas, as follows:
Precinct # Location: CORD 411 This will involve a bore or cut
The location and description of the proposed line and associated appurtenances is more fully shown by the
plat of such line attached to this application. The line will be constructed and maintained on the County
right-of-way in accordance with governing laws. And installed at a depth of 24" to 30" below the lowest
level of the bar ditch.
The applicant agrees to remove or relocate such fixtures at his own expense so as to permit the widening changing of traffic lanes or reconstruction of the roadbed. Such removal or relocation shall be within 30
days of written notice specifying the fixtures to be moved and indicate the place on the roadway to which
they shall be replaced.
Notwithstanding any other provision contained herein, it is expressly understood that tender of this notice
by the undersigned does constitute a waiver, surrender, abandonment or impairment of any property right
franchise, easement, license, authority, permission, privilege or right now granted by law or may be grant
in the future and any provision of provisions so construed shall be null and void.
The Commissioner of the above precinct will be notified of the time and date of installation at least 24
hours in advance.
This permit will become null and void if work is not completed within 90 days from date of acceptance by the Brown County Commissioners Court.
