- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Kelton moved that the minutes of the February 20, 2018 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Worley seconded the motion and the Court voted 3-0 to approve.
 - C. Recognition of visitors.
- D. Matter of new business to be presented to the Court for its consideration and action as appropriate. Items may not be taken in the order that they are listed.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, Commissioner Worley moved that the Court lift the burn ban that is currently in place. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.

Item #2: Carl Greer, Maintenance Supervisor-Consideration and possible approval for outside structural damage repair of courthouse. Carl Greer, Courthouse Maintenance Supervisor, presented two estimates for repair of outside structural damage to the courthouse. The two estimates were from Lucero Enterprises, Inc.
