- A. Opening prayer. Rick Phelps led the Court in the invocation.
- B. Reading and approval of minutes. Commissioner Worley moved that the minutes of the April 30, 2018 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Ray West, County Judge-Consideration and possible approval of transfer of Brown County's interest in Lot 4, Block 3, Live Oak Acres Addition in Early, Texas to the City of Early, Texas.

After discussion, with City of Early Administrator Tony Aaron, Commissioner Kelton moved that the Court approve the transfer of Brown County's interest in Lot 4, Block 3, Live Oak Acres Addition, in Early, Texas, to the City of Early, Texas. A Deed Without Warranty was prepared, signed and filed in the County Clerk's Office. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #1)

Item #3: Rick Phelps-Consideration and possible approval to clean monuments in front of courthouse. After discussion, Commissioner Kelton moved that the Court approve Rick Phelps to clean the monuments in front of the courthouse, subject to him receiving approval from the Texas Historical Commission concerning the process of cleaning. Judge West seconded the motion and the Court voted 5-0 to approve.

Item #4: Joyce Leidig & Jane Master, VFW Auxiliary-Consideration and possible approval of military display. After discussion, with Joyce Leidig, Commissioner Kelton moved that the Court authorize the VFW Auxiliary to place a military display, in the hall of the courthouse, honoring the 259 Brown County soldiers killed in action. Commissioner Worley moved that the Court approve the US Special Operation Forces Command to conduct military training exercises, in Brown County, beginning June 1, 2018 and ending May 31, 2021. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.
