

- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the November 5, 2018 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.

Item #1: Joel Kelton, Pct 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.

Item #2: Larry Franks, Elections Administrator-Canvas

Item #3: Larry Franks, Elections Administrator-Canvas

November 6, 2018 Special Election. Larry Franks, Brown County

Elections Administrator was present to canvas the votes, for the

Special Local Option Election, held on November 6, 2018. He

presented the Official Results and the Precinct by Precinct Report, to

the County Clerk, for filing. (Exhibit #3 and Exhibit #4)

Larry Franks, Brown County Elections Administrator, also presented the Canvass of General Election, certifying that the figures on the tally sheets correspond with the figures on the returns.

Item #4: Vance Hill, Sheriff-Discussion on repairs to jail kitchen. After discussion, with Sheriff Vance Hill and architect Jeffrey E. Heffelfinger, with Southwest Architects, Inc., concerning repairs to the jail kitchen, no action was taken.

Item #5: Vance Hill, Sheriff-Authorization to seek bids for the jail repairs. Commissioner Worley moved that the Court authorize Sheriff Vance Hill to seek bids for a remodel of the jail kitchen. Judge West seconded the motion, adding that notice be published, twice, in the Brownwood Bulletin, in accordance with Local Government Code 262, and that the notice also be posting on the Brown County website. The Court voted 4-0 to approve.

Item #6: Vance Hill, Sheriff-Authorization to accept donation from Stephen and Mary Birch Foundation. Commissioner Kelton moved that the Sheriff's Department be authorized to accept a \$10,000.00 check from the Stephen & Mary Birch Foundation, Inc. This contribution is in recognition of the Sheriff Department's services to others and will be deposited in the Sheriff Department's Donation Fund. Commissioner Worley seconded the motion and the Court voted 4-0 to approve. (Exhibit #6)

Item #7: Vance Hill, Sheriff-Authorization to purchase 1 additional set of gear for SWAT. Commissioner Worley moved that the Sheriff's Department be authorized to purchase one additional set of gear for SWAT, to be paid from the Sheriff Department's Donation Fund. Commissioner Shaw moved that the Court authorize the Sheriff's Department to accept donations, of Canary home monitoring security devices, for Law Enforcement, from a State Farm Insurance grant project, represented by State Farm Agent Mike Hall. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.

Item #10: Vance Hill, Sheriff-Authorization to accept cash donation from North Lake Community Church for the Cure Starts Now Campaign. Commissioner Shaw moved that the Court authorize the Sheriff's Department to accept a \$50.00 cash donation, from North Lake Community Church, for the Cure Starts Now Campaign. This donation will be deposited in the Sheriff Department's Donation Fund. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve.
