- A. Opening prayer. Rick Phelps led the Court in the invocation.**
- B. Reading and approval of minutes. Commissioner Traweek moved that the minutes of the January 22, 2019 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.**

**Item #1: Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding burn ban. After discussion, no action was taken. The burn ban remains lifted.**

**Item #2: Joel Kelton, Commissioner Pct. 2-Consideration and possible approval of action regarding easement on High Mesa Drive. Commissioner Kelton moved that the Court approve an easement on High Mesa Drive. The application, made by Oncor Electric Delivery, for a 30 ft easement, was approved at the January 14, 2019 meeting. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve.**

**Item #3: Gary Worley, Commissioner Pct. 1-Consideration and possible approval of installation of a water meter for TruCorp at Brown County Juvenile Justice Center. Commissioner Worley moved that the Court approve the installation of a 6 inch water main with a 6 inch meter, for the TrueCore Juvenile Justice Center. The cost will be \$19,399.57, payable to the City of Brownwood, for this service and the cost to dirt bore is \$4,500.00 payable to Steppes Creek Consulting. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #1 and Exhibit #2)**

**Item #4: Courtney Parrott, Texas A&M AgriLife Extension-Presentation on Healthy County Program. No action.**

**Item #5: Chris Webber, Dam Volunteer Fire Department Chief-Presentation on Central Texas Wildfire Academy. No action.**

**F. Consideration and approval of bills. Commissioner Shaw moved that the claims, as presented by County Auditor Jennifer Robison, be paid. Commissioner Traweek seconded the motion and the Court voted 4-0 approve. (Exhibit #4)**

**G. Adjourn. Upon motion duly made by Commissioner Traweek, seconded by Commissioner Shaw and carried unanimously, the Brown County Commissioners Court adjourned at 9:20 A.M.**


