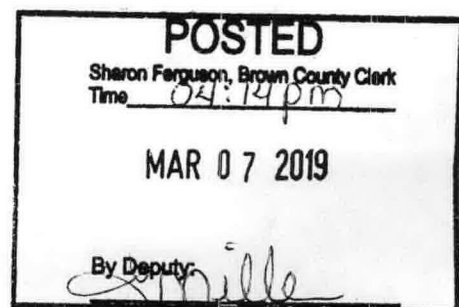

1. Declare a Quorum and Call Meeting to Order

Judge Lilly declared a Quorum and called the meeting to order.

Rick Phelps led the Court in the invocation.

There were no citizen comments.

4. Consider approval of minutes of March 4, 2019.

Commissioner Traweek moved that the minutes of the March 4, 2019 meeting be approved, as presented by County Clerk Sharon Ferguson. Commissioner Shaw seconded the motion and the court voted 4-0 to approve.

5. Consideration and Approval of Payment of any Bills needed.

Commissioner Kelton moved that the claims, as presented by Assistant County Auditor Josie Contreras, be paid. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #1)

The Total Of Funds Under The Care & Custody Of Brown County Treasurer And Auditor's Report for February, 2019, was approved after a motion by Commissioner Kelton and a second by Commissioner Shaw. The Court voted 4-0 to approve. An Affidavit, with the Report attached, was signed and prepared for publication, according to Section 114.026 of the Texas Local Government Code. (Exhibit #2)

Ann Krpoun, Brown County Treasurer, presented the Brown County Quarterly Investment Report for the Fourth Quarter of 2018, ending December 31, 2018, for filing. (Exhibit #3)

The March 11, 2019 Combined Statement Of Cash Position was presented by County Treasurer Ann Krpoun, for filing. (Exhibit #4)

7. Consideration and Approval of all appropriate action regarding the following:

A. Dr. Paul Lilly, County Judge-Announcement of FEMA applicant briefing session regarding the presidential disaster declaration for severe weather in September and October of 2018.

Brown County Emergency Management Coordinator, David Creed, briefed the Court on a meeting, to be held March 12, 2019, at 1:00 P.M., in the Commissioners Courtroom regarding the presidential disaster declaration for severe weather in September and October of 2018.

B. Dr. Paul Lilly, County Judge-Consideration and possible approval of employee change.
