COMMISSIONERS COURT OF BROWN COUNTY, TEXAS**



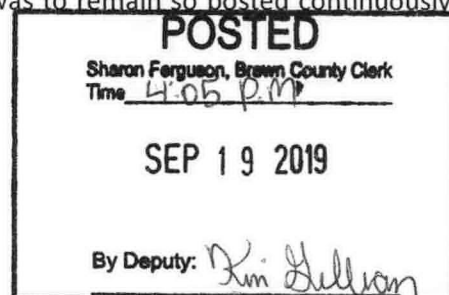

**Commissioner Kelton moved that the claims, as presented by County Auditor Jennifer Robison, be paid. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #2)**

**7. Consideration and Approval of all appropriate action regarding the following:**

- A. Mr. Joel Kelton, Commissioner Pct 2-Consideration and possible approval of action regarding burn ban.**

**After discussion, no action was taken. The burn ban remains in effect.**

**B. Bob Contreras, County Coordinator Grants & Government Affairs-Consideration and possible approval of a County Mission Statement (spon cj).**

**After discussion, with Bob Contreras, County Coordinator Grants & Government Affairs, Commissioner Kelton moved that the Court adopt a County Mission Statement. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #3)**

**Commissioner Traweek moved that the Court approve a Notice Of Special Election, for November 5, 2019, as presented by County Elections Administrator Larry Franks. Commissioner Shaw seconded the motion and the Court voted 4-0 to approve. (Exhibit #5)**

**E. Larry Franks, County Elections Administrator-Consideration and possible approval of new election judges (spon cj).**

**Commissioner Shaw moved that the Court approve the Republican, Democrat, and Early Voting Ballot Board Judges for September 1, 2019 through August 31, 2021, as presented by County Elections Administrator Larry Franks. Commissioner Traweek seconded the motion and the Court voted 4-0 to approve. (Exhibit #6)**

**F. Larry Franks, County Elections Administrator-Presentation on replacing pollbooks for Voter check-in (spon cj).**

**County Elections Administrator Larry Franks updated the Court on the need for replacing poll books to be used to check in voters at elections. No action was taken.**

**Judge Lilly adjourned the Brown County Commissioners Court at 9:36 A.M.**


